DECLARATION

1. I, the undersigned, in consideration of and as a condition of acceptance of my entry in the 2010 Red Deer Highland Games, for myself, heirs, executors and administrators hereby waive any and all claim, right of cause of action which I or they might otherwise have for arising out of injury, damage or claim of any description whatsoever which I may suffer or sustain in the course of or consequent upon entry or participation in the said event.
